## Notice of Model Closure – effective 30 September 2024

The Trustee of Australian Practical Superannuation, a part of YourChoice Super, a sub-plan of OneSuper, Diversa Trustees Limited ABN 49 006 421 638 RSE Licence Number L0000635 AFSL Licence No 235153 (Diversa), is writing to advise you of some important changes to the investment options available in the plan which will come into effect from **30 September 2024**.

As part of the Australian Practical Superannuation commitment to help you achieve better retirement outcomes, we have reviewed our investment menu and decided to close the following Model Portfolio <<insert model name>>. This decision has been made due to the Model Portfolio not reaching a size that would enable the product to maintain competitive fees for members in the future. This change will take effect from **30 September 2024**.

### What action do you need to take?
