# Am I eligible to receive my Superannuation payment if I am permanently departing Australia?

Yes, you are entitled to any earnings you have built up in your Super while on an eligible temporary Australian visa issued under the Migration Act 1958 (excluding subclasses 405 and 410). This does not apply to UK QROPS earnings.

You can apply to the Australian Expatriate Superannuation Fund after you have departed and left Australia using the claim form below.

Note: This payment is for temporary residents only. If you are an Australian or New Zealand citizen or permanent resident of Australia this form doesn't apply to you.

We recommend that you seek professional financial advice before making any decision.

# I am a New Zealand citizen and I am leaving Australia permanently are there any other options to me?

## What do I need to do to claim my Superannuation once I have departed Australia?

#### Where your Superannuation value is above \$5,000

If your Superannuation value is greater than \$5,000, please complete the form below once your visa has been cancelled or expired and supply the following documents:

- 1. We will require a Certification of Immigration Status from the relevant department with the Australian Government as evidence that your Temporary Resident visa has ceased to be in effect and that you have left Australia. (You can submit your claim through the ATO by submitting your claim online via the <u>Departing Australian Superannuation Payment Form</u> or submitting a paper version by following the ATO process <u>Applying for a Departing Australian Super Payment</u>
- 2. An original certified copy of your Australian financial institution bank account statement that states your full name, address and account details. Note payment shall be paid to this account after sufficient evidence has been provided. (Note your bank account can be a joint bank account but it cannot be solely in another person's name, as payment must be made to you the client). Please refer to our <u>Document Certification Requirements Guide</u> availble on our website.
- 3. We shall require certified proof of identity to comply with the Anti-Money Laundering and Counter-Terrorism Financial Act 2006. (Please refer to our <u>Proof of Identity Form 9</u> on our IVCM website

If your Superannuation value is less than \$5,000, please complete the form below and provide the following documents:

#### How long will it take for my Super to be paid to me?

We look to pay your Super payment in accordance with your nominated method of payment within 10 to 15 working days of receiving all requirements. Note assets may be required to be sold and therefore can result in longer time frames.

#### What does WHM stand for?

WHM stands for Working Holiday Maker. You are a Working Holiday Maker if you hold a visa 417,462 or an associated bridging visa.

#### Don't include the Departing Australian Superannuation Payment in your Tax Return
